Limited 25-year residential and 5-year commercial warranty for C.R. Plastic Products[®] high-density polyethylene (HDPE) frames.

C.R. Plastic Products warranties to the original purchaser for a period of up to 25 years for residential use and up to 5 years for commercial use from the date of the original invoice, under normal use. C.R. Plastic Products' HDPE products shall be free from material defects and shall not splinter, crack or sustain structural damage.

Transferability: This limited warranty is non-transferable.

General Warranty Conditions

C. R. Plastic Products Inc. shall not be liable for any failure, defect or damage resulting from or connected with the following:

- C.R. Plastic Products HDPE products are made with automotive grade UV stabilizers to minimize fading; however, upon exposure to the sun all colors may fade to some degree over time.
- Color or pattern variance between any new replacement section or pieces and other sections or pieces. (We reserve the right to
 discontinue or modify any product line or color without notifying the original purchaser. If the original piece is not available, we
 retain the right to choose to provide replacement material of equal value or quality).
- Damage caused by acts of God, accident, neglect or abuse.

Some expansion and contraction is to be expected due to extreme changes in humidity and temperature. **C.R. Plastic Products** does not recommend the use of pressure washers. Please refer to our Product Care/Maintenance Instructions.

Swivel Component, Gliding Mechanism, and Stainless Steel Hardware

The swivel component and gliding mechanism are warranted not to structurally fail for five years of residential use or three years of commercial use. Stainless steel hardware is warranted not to structurally fail for a period of up to five years for residential use and three years for commercial use (from date of purchase).

Sunbrella Fabric Warranty

Sunbrella warranties to the original purchaser a five year limited warranty for upholstery and specialty fabrics from date of purchase. This warranty does not apply to normal wear and tear effects on our cushions, headrests, lumbar and throw pillows by regular use. Neither does it cover damage due to unauthorized repairs or alterations, negligence, misuse or abuse, improper assembly, improper cleaning, and acts of God. For more warranty details, please refer to www.sunbrella.com. This warranty also covers any defects in the manufacturing and workmanship of the listed products for a period of 90 days.

Cushions

C.R. Plastic Products Inc. warranties to the original purchaser for a period of one year from date of purchase. It does not cover damage due to unauthorized repairs or alterations, negligence, misuse and abuse, improper assembly, and acts of God.

Resell Product Warranty

For products that are sold by C.R. Plastic Products but of another manufacturer, please refer to their specific product warranty. Our limited warranty covers the original owner, and is non-transferable.

The original purchaser is responsible for providing proof of purchase, pictures of the defect and a written description. Possible solutions are replacement or repair of the defective furniture, replacement or repair of defective component, or authorized repairs by a third party. Warranty claims may be submitted to any of our authorized C.R. Plastic Products Inc. Dealers or directly to C.R. Plastic Products Inc. Once the documentation has been received and evaluated, the customer will be notified of the solution. If the product is not returned within 60 days of date of purchase, the customer is responsible for all shipping charges that may apply.

This warranty is effective for products purchased on or after September 1, 2018. Subject to CRP inspection and/or assessment.

CARE & MAINTENANCE INSTRUCTIONS

Thank you for purchasing our outdoor furniture manufactured by C.R. Plastic Products Inc.

In order to maintain your outdoor furniture, we highly recommend the following steps be taken in order to keep the products looking clean and new.

- 303® Patio Furniture Cleaner [this product is specifically designed to clean resin and plastic furniture]
- 303[®] Patio Furniture Protectant Ithis is the world's most powerful UV screening product]
- Mr. Clean Magic Eraser
- Soapy water and a sponge
- Earth Scrub [recipe below]

What to Avoid:

Pressure Washers. When the nozzle is placed too close to the plastic it could chew and/or fray the plastic leaving a fuzzy look to the plastic and allowing atmospheric dirt and particles to get inside the plastic. Over time the furniture will look dirty and will never clean to its original look.

Earth Scrub Recipe - For Cleaning C.R. Plastic Products Outdoor Furniture Effectiveness Rating: 90% - 100%

Ingredients:

- 16 oz. squirt bottle [dish soap bottle]
- 1 ²/³ cups baking soda
- ½ cup of liquid soap [castile soaps/Dr. Bronner's soap, Palmolive or Ivory liquid dish soaps, do not use dishwasher detergents]
- 2 tbsp. vinegar

Instructions:

- In a mixing bowl, add $1^{2/3}$ c. baking soda with $\frac{1}{2}$ c. of liquid soap.
- Mix thoroughly.
- Add 2 tbsp. of vinegar.
- Continue mixing until all the lumps are gone.
- If you can pour it into the bottle easily, then you have the right consistency. If it is too thick, add more water.
- Be sure to keep the cap on this mixture will dry out.
- Shake well before using.
- Squirt on furniture, and use a nylon white-backed sponge to prevent scratching. Rinse with clean water.

This earth scrub can also be used to clean sinks, tubs, toilet bowl, floors, garbage cans and can pretty much clean up any greasy, grimy job.
